HB 1381: Elections GENERAL BILL by Persons-Mulicka

Elections; Revises provisions related to elections including signature matching, Office of Election Crimes & Security, online voter registration, oaths, citizenship, information sharing, voter records, addresses, eligibility, updating voter rolls, candidate qualifications, disclosures, special elections, identification, voter challenges, ballot canvassing, poll watchers, ballots, sample ballots, polling places, audits, notices, reporting, vote-by-mail, endorsements, canvassing boards, political parties, campaign financing, & criminal penalties.

HB 1381 undermines election security, reduces transparency, and irresponsibly allocates over \$1.5 million in taxpayer funds to overhaul an outdated voting system without clear benefits. This approach is unacceptable and borders on fraud, waste, and abuse.

On Thursday, April 2025, Director of National Intelligence Tulsi Gabbard revealed during a Cabinet meeting with President Donald Trump that U.S. investigators uncovered concrete evidence proving electronic voting machines are vulnerable to hacking and vote manipulation. Gabbard, emphasizing these long-standing risks, advocated for a nationwide

shift to paper ballots to restore voter confidence. HB 1381's reliance on potentially insecure systems directly contradicts this evidence and jeopardizes our election integrity. Instead, we must align with robust federal election security standards, as endorsed by American voters in the November 2024 election. Opposing HB 1381 is fiscally responsible and critical to protecting our elections. Failing to do so could also jeopardize federal funding, a risk we cannot afford. I urge you to vote NO on HB 1381. Thank you for your steadfast commitment to protecting our electoral process and serving our community with wisdom.
