RESOLUTION: FLORIDA ELECTION SECURITY AND TRANSPARENCY ACT OF 2025

The Florida Republican Assembly (FRA), as the stalwart guardian of fair, free, and transparent elections, hereby asserts that the integrity of our democracy depends on election processes that are beyond reproach and beyond question.

We recognize that election security stands as the bulwark against fraud, manipulation, and outside interference—threats that erode public confidence, undermine civic faith, and imperil the sacred principle of government by the people.

This resolution serves as both a mission statement and a rallying cry: to institute robust, commonsense measures that safeguard every Floridian's vote; to inject genuine transparency into electoral processes; to shield our institutions from hidden agendas—foreign or domestic; and to restore the public trust that every citizen deserves.

WHEREAS, the right to vote in free and fair elections is the foundation of our Republic; and

WHEREAS, trust in elections has eroded due to opaque processes, unreliable machines, unchecked mail-in ballots, and bloated costs that burden taxpayers; and

WHEREAS, voting machines and electronic tabulators cannot be fully trusted, being vulnerable to malfunction, manipulation, and outside interference, thereby undermining transparency and public confidence in election outcomes; and

WHEREAS, widespread mail-in ballots have proven vulnerable to fraud, abuse, and chain-of-custody failures, further eroding voter trust; and

WHEREAS, secure, transparent, and cost-effective elections are essential to restoring public confidence and civic participation; and

WHEREAS, the Florida Republican Assembly fully supports national election reform policy and affirms President Donald J. Trump's framework to restore election integrity, including secure paper ballots, voter ID, ending mass mail-in voting, and strengthening transparency;

THEREFORE, BE IT RESOLVED, that the Florida Republican Assembly (FRA) proudly endorses the Florida Election Security and Transparency Act of 2025, which provides the following key reforms:

Key Provisions

- 1. All And Only Verified U.S. Citizens Vote
 - Proof of U. S. citizenship is required to register to vote with continuous voter roll maintenance to ensure accuracy.
- 2. All and Only Legal Ballots Are Counted Using Secure Paper
 All ballots shall be hand-marked and hand-counted, printed on irreproducible paper, and produced

exclusively by US-based vendors. Electronic tabulators are prohibited, except as required for ADA compliance.

3. Single-Day Voting with Voter ID

All elections shall be conducted on one designated day—consistent with successful models in France and Taiwan—with photo voter ID required for every ballot cast.

4. Civic Engagement Program

High school and college students may assist in ballot counting for civic credit, fostering both education and public trust.

5. End Mail-in Ballots

Mail-in voting is hereby abolished. Only in-person voting shall be permitted, with the sole exception of tightly regulated absentee ballots as defined below.

6. Limited Absentee Voting

Absentee ballots shall be restricted to military personnel, first responders, the disabled, and bedridden elderly. Strict chain-of-custody procedures will be enforced.

7. Fiscal Responsibility

By eliminating costly voting systems, extended staffing requirements, and mass mail-in voting, this Act is expected to reduce election costs by up to 90%

8. Provably Secure Election Technologies

All election technologies are made, supported, and operated in the U.S.A. with certification to the latest standards and independent audits.

9. Provably Fair and Accurate Elections

Every part of the election process is auditable and audited with full transparency and issue reporting system.

Effective Date: January 1, 2026.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be transmitted to the Honorable Ron DeSantis, Governor of the State of Florida; the Honorable Speaker of the Florida House of Representatives; and the Honorable President of the Florida Senate, for their official review, consideration, and further legislative action consistent herewith.
